Photography
We often take photographs/video recordings to celebrate achievement of our pupils as part of curricular or extra-curricular activities. It is important that children cross with our crossing patrol warden, even when accompanied by an adult. The crossing patrol warden is on duty on Cedar Road at the following times:

- 8:35am to 9:00am
- 3:05pm to 3:25pm

Children may play on their yard until school begins at 8:55am, at which time they will be collected by their teacher. Parents should be aware that children will not be supervised by school staff before 8:45am. Children are still their parents' responsibility until this time, even if they are on the school playground. Children are welcome to come into the dining room for Breakfast Club from 8:30am.

Access to the school car park is difficult and there is often no space available during the school day. Parents bringing or collecting children by car are asked to park considerately on Cedar Road. In particular, cars are not to be parked on the yellow school entrance markings.

Breakfast Club

Stocksbridge Junior School's own Breakfast Club is open from 8:30am until 8:55am each morning of the school week. The school offers breakfast menu choices at very reasonable prices.

Children are also invited to join in our morning 'Wake Up, Shake Up' activity on the top yard at 8:45am.

For several years, we have been raising funds to extensively and creatively improve our outside learning environment. When Ofsted visited us in February 2015, they agreed with our area for development and left us with only one target: 'To improve the use of the school's grounds to develop outdoor learning and provide activities for pupils at playtimes.' In July 2016, we were delighted to complete phase one of Project Cedarwood!

Such a wonderful space requires thorough checks and daily upkeep to ensure it is well maintained and, therefore, safe to use. To enable us to carry out our health and safety procedures and ensure suitable levels of supervision, we must limit use of the area to within the school day. Our pupils know that they are not permitted to use the space or structures before or after school. We would like to politely request that parents do not allow younger siblings to use the space when dropping off or collecting children from school. We would also appreciate if this message could be relayed to any older children who collect their siblings from Stocksbridge Junior School.

When in school uniform, our children are encouraged to conduct themselves during, and beyond, the school day according to the values we promote at school. Our uniform

- Sweatshirt/Cardigan Navy blue embroidered with the school logo
- Polo Shirt Navy blue or white either embroidered with or without the school
- Trousers/Shorts/Skirts/Pinafores Plain navy blue or black
- Summer dresses Blue and white checks
- Footwear Dark sensible footwear, this may include trainers but not high heeled shoes
- Indoor Footwear Children should change into pumps/plimsolls/slippers before entering their classrooms

Jeans/Denim clothing (including skirts and shorts) and leggings are not allowed.

Purchasing Uniform

Stocksbridge Junior School's uniform supplier is a Sheffield based company called 'School Trends'. It is possible to have uniform delivered to your home address by ordering directly through the School Trends' online ordering facility at www.stparent. co.uk. Alternatively, parents may complete an order form which may be collected from the school office or downloaded from our school website. School Trends visit school each Thursday to collect new orders and to deliver uniform.



PE Kit

Children are asked to have their full PE kit in school each day. Each item of a child's PE kit should be clearly labelled and kept in a named bag on the child's peg. PE kit consists of

Jewellery, including rings and hooped earrings, cosmetics and false nails, are not allowed because of the dangers incurred and possible loss/damage. Children may wear a watch and a pair of small stud earrings; however, children must be able to remove their own earrings for PE lessons.

Pupils' Belonainas

Parents are requested not to allow their children to bring valuables to school. Insurance cover is not provided against loss, damage or theft of personal property of pupils and therefore, we cannot take responsibility for any such items. Children often have to bring money to school; for example, money for breakfast club or the snack stall, money for school visits or for fundraising events etc. Parents are asked to ensure that the child has a safe place in which to keep such money.

Lost Property

All clothing and personal possessions (for example, stationery, lunch boxes and water bottles) belonging to your child must be clearly labelled with your child's name. When it is not possible to return clothing or personal possessions to the rightful owner,

Food & Drinks

At Stocksbridge Junior School, all school meals are freshly prepared on site by our catering team from Taylor Shaw. Our menu works on a three week cycle, offering children a choice of healthy, balanced meals including freshly prepared vegetarian

Free School Meals

The Government currently funds schools in England to provide every child in Key Stage 1 with a hot meal at lunchtime. To continue receiving free school meals from Year 3 upwards, families need to receive certain income related benefits. For more information, please contact the staff in our school office. All applications are treated confidentially.

Dinner Money

School dinners are charged at £2.00 per day/£10.00 per week. Parents are requested to pay for their child's school dinners using our online payment system, ParentMail.

Children may prefer to bring a packed lunch to eat at lunchtime. We ask that drinks are not sent as each child is provided with fresh drinking water in the dining room. We do not have refrigeration facilities for storing packed lunches during hot weather nor do we have facilities for food that requires reheating.

Children may bring a snack for their morning break. As a school that promotes healthy lifestyles, we ask that children bring healthy snacks. Children are not permitted to bring sweets to school. Fruit and snacks are on sale in the dining-room during morning break each day.

Water fountains are available for children to use throughout the school day; alternatively children may bring a bottle of water (not cordial or fizzy drinks) to have with them during lessons. We request that water bottles have sports caps to minimise the number of spillages.

Nut Allergies

As we have children in school with allergies to nuts, it is essential to ask that parents do not provide any form of nuts for their child's snack or as part of their packed lunch. This includes sandwiches containing Nutella or peanut butter.

Key Information

Attendance

Regular and punctual school attendance is important. Pupils need to attend school regularly if they are to take full advantage of the educational opportunities available to them by law. Parents/quardians have the legal responsibility for ensuring their child's good attendance, working together with the Headteacher and Governors at our school and other professionals and agencies, to ensure that all pupils have access to learning for the maximum number of days and hours.

Reporting Absences

If your child is unwell or cannot attend school for any reason, please telephone the school office from 8:15am or leave a message on our 24-hour answerphone. If your child is ill, please be more specific about their symptoms rather than simply stating they are 'poorly' or 'not well'. A record of illnesses allows us to monitor for any emerging patterns of illness, for example, chickenpox. We request that medical appointments take place outside of the school day. If it is unavoidable, an appointment absence slip needs to be obtained from the school office prior to the appointment. Please provide evidence of your child's appointment, where

Punctuality

Children who are persistently late or absent soon fall behind with their learning. All pupils arriving after 8:55am must enter school via the main school entrance. Children who arrive after the registers have closed at 9:05am will be marked as late.

Request for Exceptional Term Time Leave

Absence from school, whatever the reason, harms the educational chances of a child. For this reason term time leave will not usually be authorised and will only be granted in exceptional circumstances in line with the following government guidance:

The current law does not give any entitlement to parents to take their child on holiday during term time. Any application for leave must be in exceptional circumstances and the headteacher must be satisfied that the circumstances warrant the granting of leave. Parents can be fined for taking their child on holiday, or for any other period of leave taken lasting five days or more taken during term time, without consent from the school. Fines are charged at £60 per parent and this can increase to £120 per parent.

Parents should complete a form and submit to the school at least twenty days in advance.

Curriculum

At Stocksbridge Junior School, we believe that our children should have a range of learning experiences that challenge, stimulate and promote independent thinking and collaborative learning. Our curriculum achieves much more than simply meets the requirements of The National Curriculum; it immerses children in exciting and inspiring themes that are packed with activities to engage, develop, innovate and express our pupils' imaginations.

In depth curriculum matrices can be found on our school website along with our half termly curriculum newsletters.

Sport

Stocksbridge Junior School has been awarded ACTIVEMARK Gold in recognition of the school's outstanding commitment to promoting the benefits of physical activity and school sport.

Our team of PE teachers deliver exceptional PE lessons to all pupils across the school each day of the week. In addition to the PE curriculum, Stocksbridge Junior School provides children with further sporting aims, such as the opportunity to participate in competitive sport with other schools and also the opportunity to participate in a wide range of extra-curricular sporting activities. Swimming

At Stocksbridge Junior School, we are committed to facilitating swimming lessons for our pupils with the aim that every child has the ability to swim unaided for a distance of at least 25 metres by the end of Key Stage 2.

Whilst in Year 4, each pupil attends a course of weekly swimming lessons at Stocksbridge Community Leisure Centre. Within the law, parents do not have a right to withdraw their children from this statutory element of the National Curriculum.

Music

All children receive normal music lessons in school, according to the National Curriculum. In addition there is the opportunity of receiving instruction in playing other instruments, such as the violin, clarinet, guitar, keyboard etc. This is a service provided by the Sheffield Music Service and has to be 'bought in'. Parents wishing to use this facility should contact the Sheffield School Music Service.

Extra-Curricular Clubs

Throughout the school year, a variety of clubs take place including:

And a vast range of sports clubs including Karate and Street Dance.

Inclusion

At Stocksbridge Junior School, we take great care to ensure that we consistently provide an educationally inclusive environment. Our inclusion policy includes provision for:

- Children with Special Educational Needs or Disability (SEND)
- Children with English as an Additional Language (EAL)
- Children who are particularly able
- Children who need additional help to develop their social, emotional and behavioural skills
- Children who are vulnerable because they are looked after by the local authority
- Children who are refugees, asylum seekers or from Traveller communities.

We work closely with parents and other colleagues from outside agencies to meet the needs of all children, providing support in school as appropriate.

Access

Every effort is made to accommodate the needs of pupils with physical difficulties. This includes securing whatever support is stated as necessary in Educational Health Care plans and making other provision as needed. It should be noted, however, that the school accommodation is on two levels and that access into the school is via steps. School does not currently have any lifts and this may present problems of mobility for some pupils.

Emergency Arrangements

The school will remain open whenever possible, but the well-being and safety of pupils and staff will also be taken into account. In the event of severe weather, we will endeavour to keep parents up-to-date with the latest information about our school through the following channels:

If, due to exceptional circumstances, the school needs to close early because of severe weather during the day, a text will be sent to parents via ParentMail and messages will be posted on our website, twitter and Facebook. Every effort must be taken to collect your child as soon as possible. No child will be sent home early unless contact with a parent, relative or responsible adult has been made.

Please make sure we have current contact numbers for every person who has parental responsibility plus the details of two additional contacts in case we need to contact you urgently.

Pupil Welfare

Children come to school to learn. A contented and secure child learns efficiently and well. In addition to organising lessons, we have to pay attention to the personal needs and wellbeing of each child on their journey through our school. Providing this support, help and guidance is our way of ensuring that each of our pupils achieves personal excellence and recognition and makes the most of the many opportunities the school has to offer. Our system of pastoral care aims, therefore, to make sure that each child enjoys a successful career at school.

Safeguarding

At Stocksbridge Junior School, the governors and staff fully recognise the contribution the school makes to safeguarding children. We recognise that the safety and protection of all pupils is of paramount importance and that all staff, including volunteers, have a full and active part to play in protecting pupils from harm. We believe that the school should provide a caring, positive, safe and stimulating environment which promotes all pupils' social, physical, emotional and moral development.

Ultimately, effective safeguarding of children can only be achieved by putting children at the centre of the system, and by every individual and agency playing their full part, working together to meet the needs of our most vulnerable children in line with: Working Together to Safeguard Children 2015 and Keeping Children Safe in Education 2015.

A senior member of the school's leadership team is designated to take the lead responsibility for dealing with child protection issues, providing advice and support to other staff, liaising with the local authority and working with other agencies. This role is also supported by several Deputy CPLOs.

Pupil Health

If you have any worries or concerns about your child's health, the school nurse may be able to assist you. The nurse has close links with doctors, teachers, health visitors and other agencies. Any information you give about your child is regarded as confidential. To get in touch with the school nurse, please contact the school office.

Medications

If your child needs to take medicine during the school day for chronic or life threatening conditions e.g. asthma or diabetes, we will make arrangements for this. You will be asked to give clear, written instructions for the administration of such medicines and your written consent. If your child needs other medicines, such as antibiotics or cough medicines, they will often be unfit to attend school. However, if they are fit enough to attend school and need medicines at regular intervals, we must ask you arrange to visit school to give such medicines yourself.

Parental Involvement

Parents are one of the most important factors in the education of a child and so we see an active partnership between home and school as essential. We hope that if ever a difficulty arises, you will feel at ease to approach the school directly. In the first instance, you are more likely to make contact with the class teacher, but the year leaders and senior staff will also be ready to be of assistance.

There is a published calendar of events at the school to which parents are always welcome. There is also a regular schedule of Parents' Evenings to discuss the progress of each individual. We feel it is very important for each child that parents make every endeavour to attend on these occasions.

Supporting Your Child At Home

Parents often ask how they can help their child at home. To keep you up to date with what your child will be learning each term, we send home the 'Curriculum News' for each year group, which details the objectives that will be covered throughout each theme. Other ways of helping your child include:

- Try to give a feeling of 'can do' confidence.
- Ensure that attendance at school is regular and punctual.
- Be aware of what he/she is learning.
- Take an interest in your son/daughter's work, progress and attainment.
- Stress the benefit of doing well at school.
- Help him/her to hold lengthy conversations to reflect on experience.
- Let your child see, if possible, you reading and writing.
- Read with your child and help them to practise their spellings and Mathematics facts.
- Encourage your child to complete all home learning tasks and return them to school on time.
- Try to have books around.

... but most of all, talk positively to your child about school life!
